Rebuilding Together San Diego Client Agreement

I agree that I will participate in the Rebuilding Together San Diego (“RTSD”) program and that my participation will be subject to and governed by the terms and conditions set forth below.

- I hereby waive any right, claim or cause of action arising as a result of my participation in any RTSD project from which any liability may or could accrue against RTSD or its officers, directors, employees, agents, volunteers, assigns, and/or successors in interest, collectively or individually (the “RTSD Personnel”) (the “Waiver”). This Waiver includes any and all rights, claims or causes of action resulting from personal injury to me, my family, or any other person on the premises of the property listed below (the “Property”), and/or damage to the Property in connection with my activities in any RTSD project.
- **RTSD and I agree that I will have no financial obligation to RTSD for or as a result of work done in connection with the applicable RTSD project(s).**
- The work performed in connection with the applicable RTSD project shall be accepted by you AS IS, and RTSD cannot and does not warrant or guarantee any of the work performed by RTSD Personnel.
- RTSD shall be obligated to finish only tasks that are started by RTSD and that are performed by RTSD Personnel. Any other task, whether or not associated with an RTSD project, shall not be the responsibility of RTSD, and RTSD shall have no liability for any such task or project.
- I agree that neither RTSD nor any RTSD Personnel will be held liable for work completed in accordance with the applicable RTSD project [plan/specification] but deemed unsatisfactory by me.
- **I warrant that I am the owner of the Property or that I have provided authorization from the landlord of the Property to have RTSD perform an RTSD project on the Property, and that the Property is the property on which RTSD and RTSD Personnel shall do all work.**
- **I agree to be present during all work performed by RTSD and RTSD Personnel.**
- I give Rebuilding Together permission to use my likeness and images of my home to further the aims and purposes of RTSD mission.
